### 3. Scrutinizer's Responsibility:

My responsibility as a scrutinizer for e-voting process is restricted to making a Scrutinizer's report of the votes cast "in favour" or "against" by the members in respect of the resolution contained in the Notice. - ii. Bigshare Services Private Limited is the Registrar and Share Transfer Agent ("RTA") of the Company.
- iii. Bigshare Services Pvt Ltd had provided a system for recording the votes of the Members through E-voting on all the items of the business as mentioned in the Notice of the Company.
- iv. Bigshare Services Pvt Ltd had set up an electronic voting facility on its website, <https://ivote.bigshareonline.com>. The Company had uploaded all the items of the business as mentioned in Postal Ballot Notice, on the website of the Company to facilitate the Members of the Company to cast their vote through E-voting. The same was also uploaded on the website of Bigshare Services Pvt Ltd and on the website of Stock Exchange i.e. National Stock Exchange of India Limited, for information of the members of the Company.
